#### **REGULAR MEETING – 7:00 PM**

- 1. CALL MEETING TO ORDER. Mayor Steve Fortenberry called the Regular Meeting to order at 7:00 PM. City Secretary Lydia Lopez polled the Council for attendance. PRESENT: Bruce, Fuller, Potter, Turner, Wachtendorf, Bancale, and Fortenberry ABSENT: None
- 2. PLEDGE OF ALLEGIANCE TO THE U.S. FLAG. Mayor Steve Fortenberry led the Pledge of Allegiance.

- 3. HEAR VISITORS ON MATTERS PERTAINING TO CITY BUSINESS. Under the Texas Open Meetings Act, the Council may not discuss, respond, or act on any comments or items not posted on the agenda. NOTE: Citizens had the opportunity to submit written comments on items listed on the agenda or under the hear visitors. Mayor Steve Fortenberry recognized Sharon Chandler. Sharon Chandler and Jim Bruns, 701 Regina, appeared to compliment the Hewitt Fire Department on a recent emergency response. No other public comment forms were submitted.
- 4. CONSIDER APPROVAL OF MINUTES OF THE BUDGET WORKSHOP AND REGULAR MEETING OF AUGUST 2, 2021, AND THE SPECIAL CALLED MEETING OF AUGUST 9, 2021.

- 5. CONDUCT THE SECOND OF TWO PUBLIC HEARINGS ON THE 2021 TAX RATE. City Manager Bo Thomas stated that the proposed tax rate is set at the de minimis rate of \$0.540102. Mayor Steve Fortenberry opened the public hearing at 7:04 PM to receive comments and called for those wishing to speak for or against the 2021 Tax Rate. No one appeared. Mayor Fortenberry closed the public hearing at 7:05 PM.
- 6. CONSIDERATION AND ACTION ON ORDINANCE NO. 2021-12 ACCEPTING THE 2021 CERTIFIED TAX ROLL. City Manager Bo Thomas read the ordinance caption into the record.

7. CONSIDERATION AND ACTION ON ORDINANCE 2021-13 ADOPTING THE 2021 TAX RATE OF \$.540102. City Manager Bo Thomas read the ordinance caption into the record and stated that a motion was provided in the backup that complies with the Texas Property Code.

**MOTION:** Council Member Charlie Turner moved that the property tax rate be increased by the adoption of a tax rate of .540102, which is effectively a 7.24% increase in the tax rate.
